

97.9 WRMF – “FREE TRIP FRIDAY”

Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- Eligibility:** The 97.9 WRMF – “Free Trip Friday” Sweepstakes (the “Sweepstakes”) is open only to individuals who are 18 years or and residents of Florida and who reside within 150 miles of Hubbard Radio West Palm Beach’s studio located at 701 Northpoint Parkway, Suite 500, West Palm Beach, FL 33407, to be eligible to win. - How to Enter:** There are two (2) ways to enter this Sweepstakes:
 - Mobile App:** To enter via this method of entry, listeners must register on the 97.9 WRMF Stream Player mobile app (“App”) at <http://www.wrnf.com/> (“Website”). Then, listen to 97.9 WRMF through the App during the Mobile App Play Period for a minimum of 4 hours per week during each Weekly Entry Pool period, to be eligible to receive one (1) entry into the random drawing per day (regardless of how many hours you listen each day that exceed 4 hours). To be entered, each registered listener must also complete and submit an online entry form found on the Sweepstakes description detail page through the App. Limit one (1) entry per person per day.

Compliance With Government Entities: Unique Travel Corp, its affiliates, and parent as well as Sandals Resorts International Limited and/or Resort, and Sponsor, and related entities shall have the right to comply with any and all orders, recommendations, or directions whatsoever given by any government entity or by persons purporting to act with such authority, and such compliance shall not be deemed a breach of these official rules, entitling the guests to assert any claim for liability, compensation or refund. All guests are responsible for checking the and entry protocols for the destination that they are travelling to in advance before they depart and ensuring that they fully understand and comply with any and all destination protocols.
