

**97.9 WRMF AFTER HOURS CODE WORDS SWEEPSTAKES**  
**Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**OPEN TO LEGAL RESIDENTS OF FL ONLY, WHO ARE 18 years of age or older.**

**BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.**

1. **Eligibility:** The 97.9 WRMF After Hours Code Words Sweepstakes (the "Sweepstakes") is open only to individuals who are 18 years or and residents of Florida and who reside within 150 miles of Hubbard Radio West Palm Beach 97.9 WRMF's studio located at 701 Northpoint Parkway, Suite 500, West Palm Beach, FL 33407, to be eligible to win. No purchase necessary to enter the Sweepstakes. Employees of Hubbard Radio West Palm Beach, LLC through its radio station 97.9 WRMF (the "Sponsor"), Walt Disney World ("Promotional Participant"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor and Promotional Participant, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
2. **Sweepstakes Period:** The Sweepstakes begins at 2:00:00 PM Eastern Time ("ET") on April 24, 2023, and ends at 6:00:00 PM ET on May 5, 2023 (the "Sweepstakes Period").
3. **How to Enter:** To enter, eligible listeners must listen to 97.9 WRMF to Jeff Miles & Meghan Lane each weekday (Mon-Fri) during the Sweepstakes Period from 2:00 PM ET and 6:00 PM ET for the *After Hours* code to be announced on-air (each, a "Code Word"). Then, open the 97.9 WRMF stream player available online on the Station's website or through the Station's mobile app (collectively, the "App"), find the Prize Details page and compete and submit the App entry form by entering the correct Code Word. Please note: you must be registered as a rewards member through the Station's App to be eligible to enter. You will have until 6:15 PM ET each weekday to enter the correct Code Word through the App (as defined in Section 4 below). Only entries with the proper Code Word will be counted as a valid entry. Limit of one (1) entry per Code Word. All entries must be received **by 6:15:00 PM ET** on the day the Code Word is announced to be eligible for that day's random

drawing. Sponsor is not responsible for lost, late, delayed, incomplete entries, including misspelled Code Words.

4. **How the Winners Are Selected:** Then, on May 8, 2023, Sponsor will randomly select one (1) Grand Prize winner from among all eligible entries received during the entire Sweepstakes Period to win the Grand Prize. Odds of becoming a Grand Prize winner will depend on the number of eligible entries received during the entire Sweepstakes Period. Decisions of Sponsor are final and binding. The potential Grand Prize winner will be notified by Sponsor via email or telephone on or about the day of the random drawing ("Winner Notification"). Failure to respond to the Winner notification within **two (2) days** will be deemed forfeiture of a winner and an alternate winner may be selected at Sponsor's sole discretion, time permitting. Sponsor is not responsible for email message notifications that are undeliverable or not received, or voicemail messages not received.
